# **MCCL Project Information**

#### **ABOUT**

In June of 2010, MCCL purchased a 5-acres lot at 19838 Sycolin Rd Leesburg VA. as the future home of Muslim Community Center of Leesburg VA for the purpose to build a masjid and Islamic Center. The development will be in several phase over many years. The project envisions a mosque for about 300 people, consisting of a main floor as the prayer area, a basement which can act as a multipurpose room and school. There is a mezzanine level which is on the second floor that will be used as the sister's prayer area. The building will also include bathroom facilities, wudu facilities, meeting rooms and a coffee shop/lounge/break room. The project will also include a parking lot, the land development work like drainage, utilities etc. This whole project would be divided into phases for ease of construction and to meet budgetary demands,


